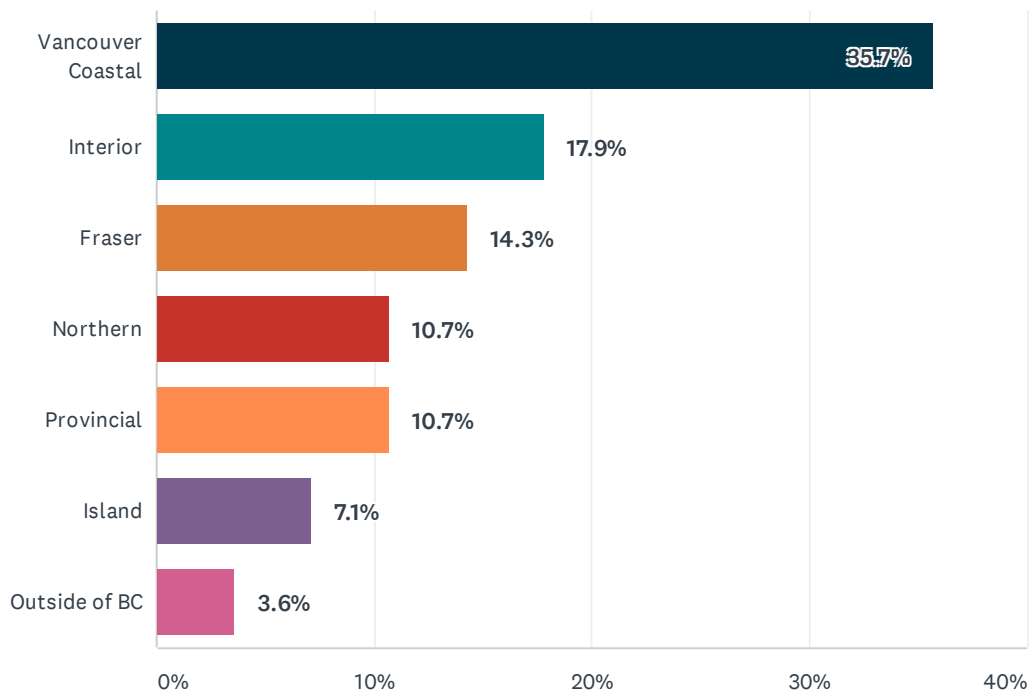


# Q1 Which of the following Health regions do you primarily work or reside in?

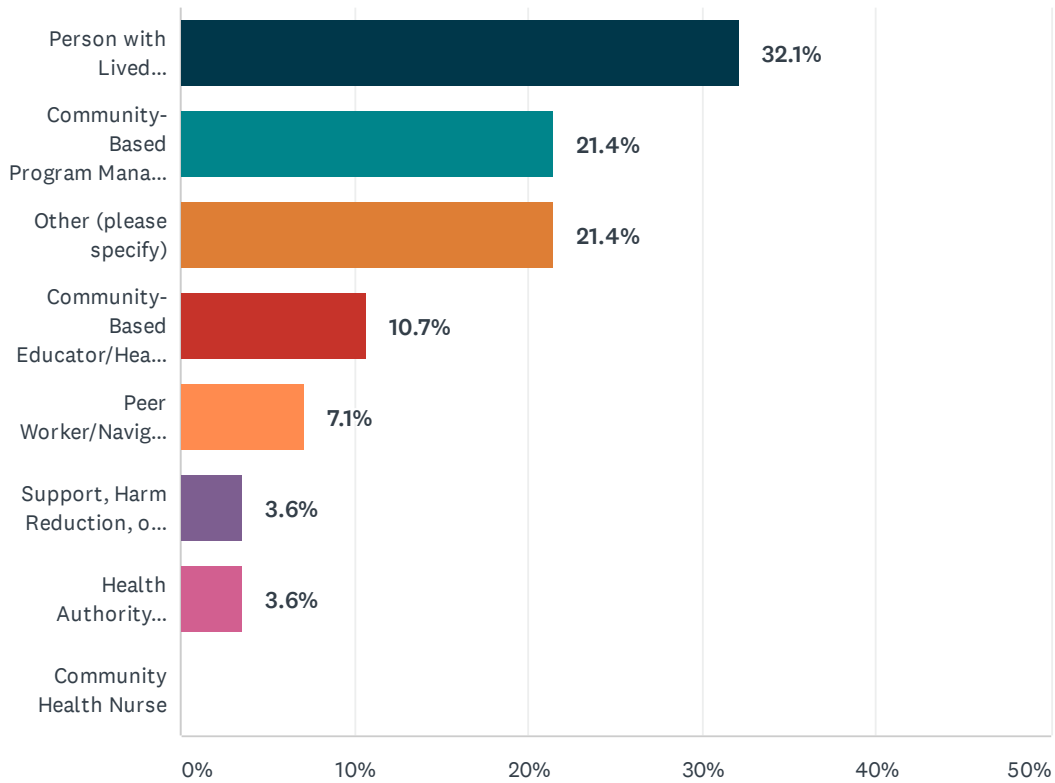

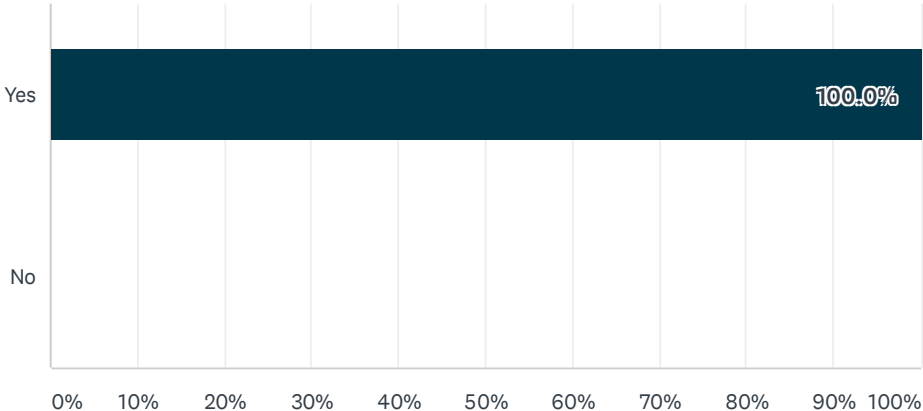

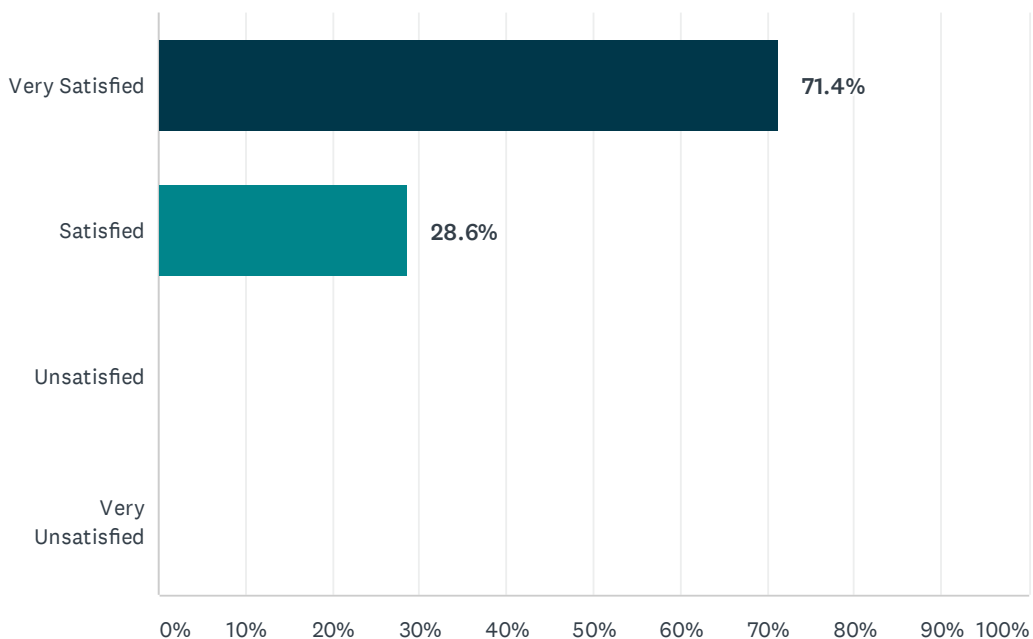

## Q11 Overall, how would you rate your satisfaction with PAN's Stories of Lived Experience event?

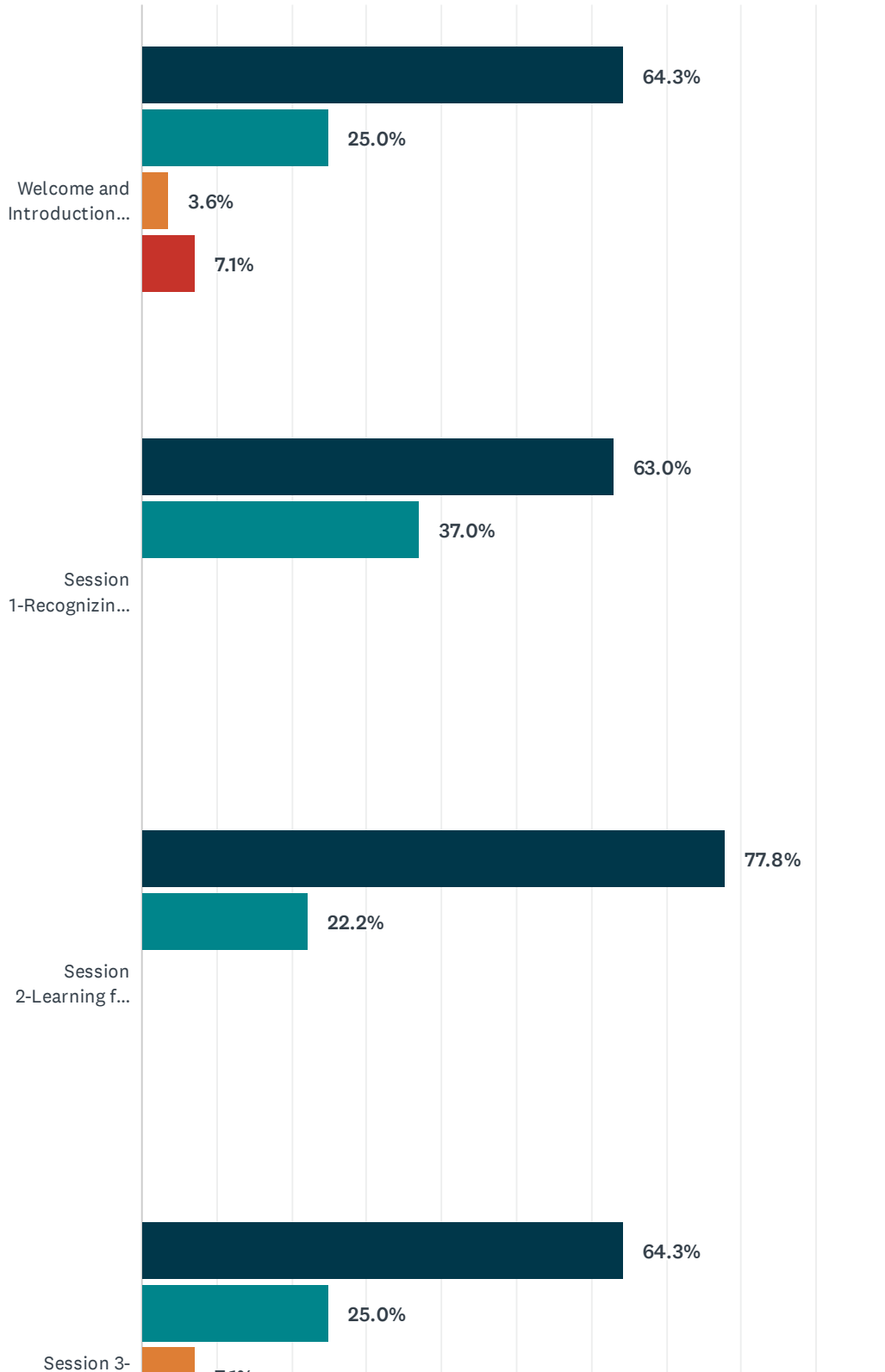

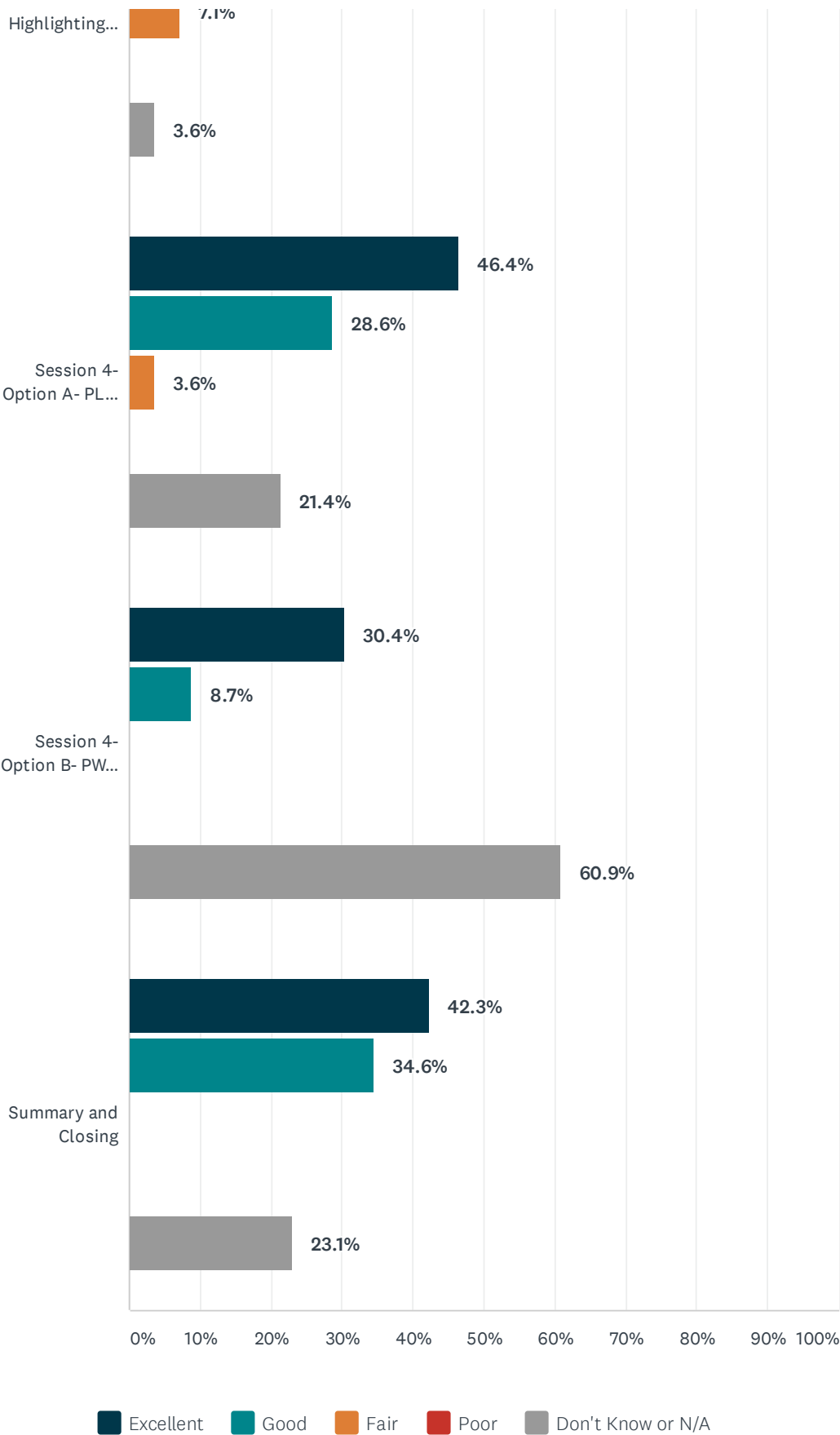

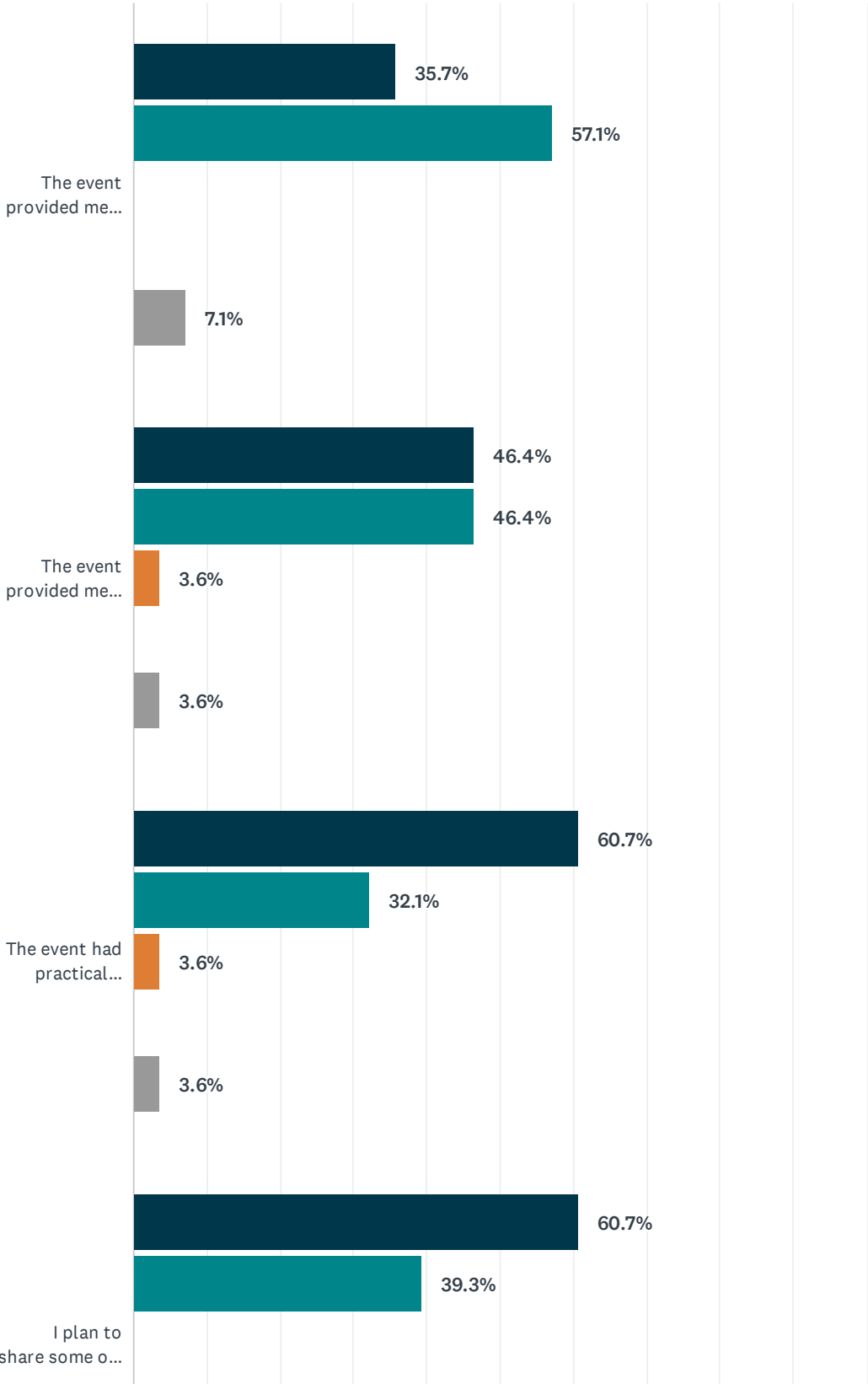

20 Honestly the only thing that was really unfortunate and uncomfortable was the gentleman who opened the stories I've lived experience event. I really appreciated including the indigenous culture but having a man spit rhetoric that could be damaging to people who are immunocompromise and have been through trauma was extremely disturbing. The gentleman who opened the event proceeded to make fun of the coronavirus and denies the need to use basic health practices like hand washing and reduced contact...to a group of people who have been or currently are immunocompromised. That really disturbed me. He also went on a tangent about how past and intergenerational trauma, learned behaviour and mental heath had nothing to do with choices and that if you made bad choices it was because you wanted to and are a bad person. That is incredibly disgusting and not aligned with scientific protocol and belief on behavior. We were sitting in a room full of people who not only had lived experience of HIV and hepatitis C, there was also a recovering addicts, alcoholics, survivors of trauma... It was incredibly maddening to see somebody say that to a room of people who have been through those things, and to have someone tell them that the things that they did or that happened to them have no merit and they are just bad people. I believe that as people in the HIV and hepatitis C field we need to prescribe to accurate scientific beliefs. What that man spewed was anti-scientific, innapropriate rhetoric that should have NO PLACE in a place where there are survivors of trauma and disease.
